A Public Meeting of the Berkeley Township Municipal Utilities Authority was held on Thursday, <u>November 12</u>, <u>2015</u> at 7:00 pm at the Berkeley Township Municipal Utilities Authority at 42 Station Road, Bayville, NJ 08721. Motion to approve the minutes from the Public Meeting on October 22, 2015: Mr. Mullikin, second, Mr. Pizzi. The motion was approved by voice vote. There were no "nay" votes. Motion Carried. Mr. Buscio abstained.

Schultes for the Well #4/Phase 1 project which will be separately authorized in a resolution tonight.

Executive Director's Report:

A.C. Schultes Payment #4 for Well #4/Phase 1 \$31,311.00:

Mrs. Nugent requested of the Board authorization to approve Payment #4 to A.C. Schultes. This pay estimate covers all work from September 1, 2015 through October 30, 2015. The total amount of the application is \$31,950.00 with a 2% retainage for \$639.00 resulting in a payment of \$31,311.00.

Engineer's Report:

Well #4 Project:

Phase I – Test Well:

Mr. Chiaravallo stated A.C. Schultes is completing the last few items in the Phase I portion of the project. CME has reviewed the submittals from A.C. Schultes.

Phase II – Production Well:

Mr. Chiaravallo stated he met with the Engineering Committee to discuss the DEP allocation increase request. Mr. Chiaravallo stated he will meet with the DEP to discuss the application submittals schedule and will report back to the Authority.

Phase VI Water Main Improvement Project:

Mr. Chiaravallo stated CME has responded to NJDEP comments regarding the Phase VI Water Main Improvement project. Mr. Chiaravallo stated the project will be advertised in December 2015. It is anticipated construction of the project will be scheduled to begin in Spring 2016.

Mr. Hale stated it would be advantageous for the Authority to request an increase in its water allocation from the DEP only if it does not cause delays with the project. Mr. Hale added the Authority should proceed with the project and request an allocation increase at a later date if there is a possibility of a delay.
