Well #4 Project:

Mr. Chiaravallo stated Well #4 is operating and back in rotation this week (week of 08/24/20). Mr. Chiaravallo stated the contractor was on site to evaluate the vibrations, alignment and communication issues. Well #4 is fully operational on manual mode.

Berkeley Township Wells:

Mr. Chiaravallo stated he and the electrical engineer did a walk through at the Berkeley Township Public Works and Municipal Building. A meeting will be set up with the Engineering Committee to discuss the observations.

Surge Protection:

Mr. Chiaravallo stated the contractor tested the system during the week of 08/10/20. The lightning protection system on the treatment plant building tested well.

Mr. Bollettieri questioned if the chart recorder was working on Well #4. Mr. Chiaravallo replied the chart recorder for the four wells is not working. PCS is the integrator for the programming and will be on site to investigate why the chart recorder is not working. Mr. Edward Cammarato questioned if the Authority is permitted to operate if the chart recorder is not recording the data. Mr. Chiaravallo replied it is not an issue because the data can be manually recorded.
