RESOLUTION OF THE BERKELEY TOWNSHIP MUNICIPAL UTILITIES AUTHORITY, TOWNSHIP OF BERKELEY, COUNTY OF OCEAN, STATE OF NJ REGARDING THE AUTHORITY'S LIGHTENING PROTECTION SYSTEM

WHEREAS, it has come to the attention of the Berkeley Township Municipal Utilities

Authority (hereinafter referred to as the "Authority") that the Lightening Protection System

(LPS) for the Authority building may be defective; and

WHEREAS, it was deemed to be in the best interest of the Authority to inspect the system and make any upgrades that are necessary for proper protection; and

WHEREAS, the failure to do so could lead to extensive damage; and

WHEREAS, the Authority authorized the Executive Director to obtain quotes to inspect and make any necessary repairs to the system; and

WHEREAS, the Executive Director has obtained a bid to perform the work necessary to repair the LPS and electrical ground grid; and

WHEREAS, a bid has been received that has been reviewed and approved by the Authority engineer as being responsive to the needs of the Authority;

NOW THEREFORE BE IT RESOLVED this 19th day of December, 2019, by the Berkeley Township Municipal Utilities Authority as follows:

- The Executive Director is hereby authorized to enter into an agreement with Bahr
 & Sons Electrical Contractors, 82 Shorewood Drive, Bayville, NJ to inspect and make necessary repairs and modifications to the LPS.
- 2. The total amount expended for labor and materials for said repairs shall not exceed Fourteen Thousand Seven Hundred Twelve Dollars and Third Two Cents (\$14,712.32).

3. The Authority hereby authorizes and directs the Chairperson, Secretary and

Executive Director to execute any and all necessary documents in order to

implement the intent of this Resolution.
