2. This release is subject to the posting of a maintenance guarantee in the amount of 15% of the cost of improvements or \$9,994.45 for a period of two (2) years from

the date of this Resolution.

implement the intent of this Resolution.

RESOLUTION OF THE BERKELEY TOWNSHIP MUNICIPAL UTILITIES AUTHORITY, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING A LUMP SUM PAY INCREASE FOR THE YEAR 2019

- 3. These lump sum payments shall be added to the respective employee's base salary for calculations of their increase in hourly rate for the 2020 calendar year and thereafter.

4. The Authority hereby authorizes and directs that the payments set forth herein be made to the employees on or before the / 6th day of September, 2019.
